## **HEREBY DECIDES:**

Article 1: (1) A competitive entrance examination for the admission of five hundred (500) students into the first year of the Bachelor's degree programme in Engineering Sciences and the Engineering programme at the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, for the Belabo and Yokadouma campuses has been launched for the 2024/2025 academic year in the following centres: Bafoussam, Bertoua, Douala, Garoua, Maroua, Ngaoundéré et Yaoundé.

- (2): Once the admission results are published, the number of places per site will be distributed as follows: Belabo (400 places) and Yokadouma (100 places).
- Article 2: (1) The fields of study open for the competitive entrance examination for the campus in Belabo are as follows:

- (3) Admitted students in each of the two cycles at the end of their second year of training will have to choose from the above-mentioned fields for the rest of their training.
- Article 3: (1) The competitive examination entrance is open in one session to Cameroonians and Foreigners of both sexes without age limitation.

Article 4: If successful in the competitive entrance examination, candidates awaiting the results of the aforementioned official examination shall be admitted into the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua at Belabo, only upon presentation of an testimonial of success or the results slip of the certificate obtained in 2024, and before the deadline set by the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua.

## Article 5: (1) The application file shall comprise the following:

- a- An online individual record form duly filled by the candidate on the entrance examination page of the school's website: <a href="http://www.isabeeb.cm">http://www.isabeeb.cm</a>;
- b- A photocopy of the National Identity Card;
- c- A certified true copy of the birth certificate (not more than 3 months old);
- d- Certified photocopies of the Probatoire or the GCE O/L and the Baccalaureate or the GCE A/L transcripts;
- e- Certified photocopy of the Baccalaureate or the GCE A/L, or any certificate recognized as equivalent to them by the Minister of State, Minister of Higher Education, which must not be more than three (03) months old from the date of issue, or a certified photocopy of results slips of the Baccalaureate or the GCE:AL;
- f- A medical certificate of physical fitness issued by a state medical doctor;
- g- A self-addressed A4-size stamped (1.000 francs CFA) envelope;
- h- A receipt of twenty thousand (20 000) FCFA as examination fee.
- (2) Application file must specify the Campus chosen by the applicant in the event of admission.

Article 6: The examination fee of twenty thousand (20 000) francs CFA shall be payed only through EXPRESS UNION with a receipt issued on payment. The receipt must be attached to the candidate's application file. The examination fee, which is non-refundable, shall be used to cover expenses related to the organization of the examination. Any other means of payment shall not be accepted.

Article 7: The complete application file shall reach either the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua at Belabo, or the Regional Delegation of the Ministry of Secondary Education of the candidate's place of residence, latest the 12th of September 2024 at 5 pm. However, foreign candidates of countries in the CEMAC region shall deposit their files at the office of the Cameroonian diplomatic representatives of their respective countries.

Article 8: The written part of the entrance examination will take place on Saturday 21st September 2024 in the following locations of the centers: Bafoussam (IUT-Fotso Victor of Bandjoun), Bertoua (Lycée Scientifique), Douala (Lycée of Deido), Garoua (Lycée Classique and Moderne), Maroua (Collège of Espoir), Ngaoundéré (Lycée Classique and Moderne) and Yaoundé (Lycée Technique Commercial of Ngoa Ekelé).

Article 9: (1) The entrance examination shall comprise candidates' academic performance that will account for 25% of the assessment, and three written papers that will represent 75% of the assessment.

(2) Marks of file to study shall be determined the candidate's secondary school performances.

Article 10: (1) The syllabus is that of Première and Terminale series mentioned above for candidates of the Francophone Sub-system, or for Lower and Upper Sixths of these series for candidates of the Anglophone Sub-System.

Article 11: At the end of the deliberations, the jury shall prepare the list of successful candidates following the different groups and in order of merit for each campus and the results shall be published by the Minister of State, Minister of Higher Education.

Article 12: The jury's make-up mentioned in article 11 is specified by the Minister of State, Minister of Higher Education in conformity with the rules and regulations in force.

Article 13: The Rector of the University of Bertoua, the Director of University Accreditations and Quality, and the Director of the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, each in his own sphere are responsible for the implementation of this decision which shall be registered and published in English and French, wherever necessary.
