### **DECIDES:**

Article 1: A competitive entrance examination for the admission of one hundred and twenty (120) students into the third year of the Master of Engineering program at the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo,

Article 2: The fields of study open for the competitive entrance examination and the places available are given as follows:

Article 3: (1) The competitive exam shall be written in one session and is open to Cameroonians and foreigners of both sexes and with no age limitations.

(2) The following table indicates the required qualifications for candidate's eligibility:

Article 4: (1) The program of the competitive exam is of the type GCE A level plus 2 years or similar to those used in preparing for the diplomas stated above and according to the options and educational subsection.

(2) The competitive examination comprises a written test on the specialty of the candidate, a test on general knowledge and a test on bilingualism.

Article 5:If successful in the competitive entrance examination, candidates awaiting the results of the aforementioned official examination, shall be admitted into the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo, only upon presentation of an testimonial of success or the results slip of the certificate obtained in 2025, and before the deadline set by the Minister of Higher Education.

Article 6: The application file shall comprise the following:

- a- An online individual record form duly filled by the candidate on the entrance examination page of the school's website: http://www.isabeeb.cm;
- b- A photocopy of the National Identity Card;
- c- A certified true copy of the birth certificate (not more than 3 months old);
- d- A transcript of the as the HND BSc BA as the case may be;
- e- Certified photocopy of the HND, BSc or BA, or any certificate recognized as equivalent to them by the Minister of State, Minister of Higher Education, which must not be more than three (03) months old from the date of issue, or a certified photocopy of results slips of the result slips if applicable;
- f- A medical certificate of physical fitness issued by a state medical doctor;
  - g- A self-addressed A4-size stamped (1.500 francs CFA) envelope;
  - h- A receipt of twenty thousand (20 000) FCFA as examination fee;
  - i- A certificate of non-violation issued not more than three months.

<u>Article 7</u>: The payment of the examination fee of twenty thousand (20 000) francs CFA shall be made only through EXPRESS UNION with a receipt issued on payment. The receipt must be attached to the candidate's application file. The examination fee is non-refundable. Any other means of payment shall not be accepted.

Article 8: (1) The complete application file shall reach either the Admissions Office of the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo, or the Regional Delegation of the Ministry of Secondary Education of the candidate's place of residence, latest the 12<sup>th</sup> of September 2025at 05 pm prompt.

- (2) Foreign candidates of countries in the CEMAC region shall deposit their files at the office of the Cameroonian diplomatic representatives of their respective countries.
- (3) Only candidates with complete files will be admitted to write the competitive examination. Candidates will be required to present the following documents; national identity cards or a receipt of deposition of documents for its making, or a valid student identity card, a receipt testifying the deposition of examination documents and a receipt of the payment of examination dues.

Article 9: The written part of the entrance examination will take place on Saturday 21st September 2025 at the following locations and centers: Bafoussam (Lycee Technique de Bafoussam), Bertoua (Lycée Scientifique), Douala (Lycée de Deido), Garoua (Lycée Classique et Moderne), Maroua (Collège de l'Espoir), Ngaoundéré (Lycée Classique et Moderne) and Yaoundé (Lycée Technique Commercial de Ngoa Ekelé).

Article 10: (1) The entrance examination shall comprise 3 tests making 75% and a cursus mark accounting for 25% of the total marks.

(2) The cursus mark shall be determined by the candidate's academic performance and the number of years spent to have the required certificate.

<u>Article 11</u>: At the end of the deliberations, the jury shall prepare the list of successful candidates following the different series and in order of merit and the final results shall be published by the Minister of State, Minister of Higher Education.

Article 12: The composition of the jury mentioned in article 11 is specified by the Minister of State, Minister of Higher Education, in conformity with the rules and regulations in force.

<u>Article 13</u>: The Rector of the University of Bertoua, the Director of the Department of University Accreditations and Quality, and the Director of the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, each in his sphere, is responsible for the implementation of this Decision, which shall be registered and published in English and French, wherever necessary.
